Please understand that the purpose of the study is to explore the process and impact of induction coaching and *not* to evaluate coaching or teaching. Participation in this study will include:

- 3 individual interviews scheduled at your convenience in the fall, winter and spring of the 2013-14 academic year.
 - Interviews will last up to 45 min. and include approximately 10 questions to understand how new coaches develop, conceptualize and enact their mentoring practice.
 - Interviews will be recorded and participants may view and have final approval on the content of interview transcripts
- 1 ninety-minute observation to gain contextual understanding and observe coaches' interactions with new teachers during classroom instruction and debriefing sessions.
 - XXX will take field notes during classroom observations and debriefing sessions to capture the ways coaches interact with new teachers' and students (e.g. taking observational notes, asking reflective questions, whispering to students)
 - Participants may view field notes and have final approval on the content of field notes

Your participation is voluntary and can be discontinued at any time without penalty or bias.
